



**Position Title:** Summer Camp Ropes Program Counselor

**Reports To:** Camp Director

**Work Location:** In person, Scarborough, Maine

**Job Type:** Full Time, Seasonal, 37-40 hours per week

**Work Schedule:** Monday-Friday, primarily day shift with 2-3 overnights required per season

### **Job Summary**

Do you love working with kids? Are you passionate about making a difference in the lives of youth? Do you want to work outdoors all summer long? Do you want to develop your leadership skills and gain valuable training and experience in the field of outdoor education? This may be the perfect job for you! At Camp Ketcha we hire over 100 Summer Camp staff to lead our students and our programs in our dynamic day camp set on 107 acres of fields, woods, marsh and wetlands in Scarborough, Maine. Program Counselors are responsible for developing curriculum (with assistance from the Camp Director), and teaching and supervising campers in a specific program area. Program counselors must set and follow through with staff and camper expectations as it pertains to the program curriculum. Program Counselors must be 18 years of age or older and be able to complete First Aid, CPR, AED training and certification before starting work.

The Ropes Program Counselor is responsible for planning and implementing programming for the Ropes program area. This includes working with children aged 4-14 in an outdoor setting and keeping them engaged in age-appropriate ropes and teambuilding enrichment for a full 1 hour programming block. This can include activities such as low ropes, high ropes, team building initiatives, field games, problem solving challenges, and exposure to a wide array of ropes and team building activities. The Ropes Program Counselor should prepare programming that aligns with their strengths while also making sure that campers receive a diverse ropes and teambuilding experience overall. Ropes course staff will be responsible for participating in 2 overnight trips to Salt Pump Climbing Gym for our Sr. Rock & Rope Specialty Camps. This position also requires at least level 1 challenge course practitioner certification/training or the ability to complete this before starting.

### **Responsibilities**

- Create and lead program area activities with campers ages 4-14
- Demonstrate sound judgement and establish a nurturing atmosphere in which campers feel safe, engaged, and included
- Communicate with all campers and staff in a positive and respectful manner
- Give clear and instructions for activities, considering various learning styles and listening abilities of each age group
- Maintain a clear, organized and safe program area including the inventory and maintenance of all program equipment
- Develop and submit weekly activity plans to the Camp Director prior to the start of each camp week
- Ensure campers and staff adhere to camp expectations
- Address behavior issues as trained in a timely manner
- Other duties as assigned
  - Summer camp is a collaborative and fast paced environment that requires flexibility and the ability to lend a hand wherever needed. Other duties as assigned may include, but is not limited to, daily cleaning tasks or working with various age groups, positions, camps, or programs including our childcare programming. All summer staff will be expected to demonstrate flexibility to ensure our summer programming runs as smoothly as possible.

### **Required Job Qualifications**

- Experience working with children and youth
- Excellent verbal and written communication skills
- Ability to prepare and lead lesson plans and adapt them to various age groups
- Commitment to Ketcha Outdoors' mission, vision, and values
- Knowledge and appreciation for program area
- Basic computer literacy skills including word processing and emailing
- Detail oriented, ability to work independently, multi-task, and enjoys interfacing with other staff at all levels
- Ability to ensure safety for yourself and all program participants

- High degree of personal integrity and professional conduct
- High degree of flexibility and dependability
- Mandated Reporter Training (to be updated every 3 years)
- CPR/First Aid Certificate (to be updated every 2 years)
- Comfortable in front of large groups of campers
- Able to lead field games and team building initiatives
- Able to facilitate both high and low ropes activities
- Knowledge and appreciation for group facilitation and the ability to plan based on group needs and effectively debrief with groups
- Comfort at height
- Ability to create and lead activities with campers ages 4-14
- Level 1 challenge course facilitator training or ability to complete before the start of the season

#### **Preferred Job Qualifications**

- Certification related to program area
- High School Diploma or GED Certificate

#### **Essential Job Functions**

- This position belongs to a class of employees referred to as Essential Personnel. Essential personnel are those needed on site to meet the needs of our camper and general camp operations. Essential personnel must report to work during their regularly scheduled hours, unless directed otherwise by a supervisor.

#### **General Work Environment and Physical Demands**

The physical demands and work environment characteristics described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

This position requires the employee to be able to pass a Complete Background Check including the National Sex Offender Registry and work outdoors for long periods of time and in light rain, heat or cold. While performing the duties of this job, the employee is occasionally required to stand; walk; sit; run; use hands to finger, handle, or feel objects, tools or controls; reach with hands and arms; climb stairs; balance, stoop, kneel, crouch or crawl; talk or hear; taste or smell. The employee must occasionally lift and/or move up to 50 pounds. While performing the duties of this job, the employee is exposed to weather conditions prevalent at the time. The noise level in the work environment is usually moderate. This position is subject to a number of inherent risks associated with farm activities. There is a potential exposure to dander of animals.
