



**Position Title:** Summer Camp Specialty Program Head Counselor

**Reports To:** Camp Director

**Work Location:** In person, Scarborough, Maine

**Job Type:** Full Time, Seasonal, 37-40 hours per week

**Work Schedule:** Monday-Friday, primarily day shift with 2-3 overnights required per season

### **Job Summary**

Do you love working with kids? Are you passionate about making a difference in the lives of youth? Do you want to work outdoors all summer long? Do you want to develop your leadership skills and gain valuable training and experience in the field of outdoor education? This may be the perfect job for you! At Camp Ketcha we hire over 100 Summer Camp staff to lead our students and our programs in our dynamic day camp set on 107 acres of fields, woods, marsh and wetlands in Scarborough, Maine. Specialty Camp Head Counselors hold a fun and dynamic role at Camp Ketcha. In collaboration with the Camp Director, they lead the planning and delivery of specialty camp programming while supervising specialty camp counselors to ensure high-quality, engaging experiences for campers. Head Counselors must be 18 years of age or older and must complete First Aid, CPR, and AED certification prior to the start of employment.

The Specialty Camp Head Counselor is responsible for developing and organizing specialty camp curriculum alongside the Camp Director, as well as leading and teaching activities across a range of specialty areas. They supervise and support specialty camp counselors and work directly with campers ages 4–14, providing age-appropriate, themed activities in both indoor and outdoor settings. Camp programming may include counselor-led activities, program area sessions, guest presentations, or field trips. Head Counselors must be able to adapt plans based on camper needs and program goals, ensure all programming is safe and enriching, and uphold Camp Ketcha's values and expectations.

This role is ideal for energetic leaders with a passion for youth development, creativity in programming, and strong ability to engage participants and collaborate with staff.

### **Responsibilities**

- Create and lead program area activities with campers ages 4-14
- Demonstrate sound judgement and establish a nurturing atmosphere in which campers feel safe, engaged, and included
- Communicate with all campers and staff in a positive and respectful manner
- Give clear and instructions for activities, considering various learning styles and listening abilities of each age group
- Maintain a clear, organized and safe program area including the inventory and maintenance of all program equipment
- Develop and submit weekly activity plans to the Camp Director prior to the start of each camp week
- Drive a 14-passenger bus to and from field trip locations throughout Maine
- Ensure campers and staff adhere to camp expectations
- Address behavior issues as trained in a timely manner
- Other duties as assigned
  - Summer camp is a collaborative and fast paced environment that requires flexibility and the ability to lend a hand wherever needed. Other duties as assigned may include, but is not limited to, daily cleaning tasks or working with various age groups, positions, camps, or programs including our childcare programming. All summer staff will be expected to demonstrate flexibility to ensure our summer programming runs as smoothly as possible.

### **Required Job Qualifications**

- Experience working with children and youth
- Excellent verbal and written communication skills
- Ability to prepare and lead lesson plans and adapt them to various age groups
- Commitment to Ketcha Outdoors' mission, vision, and values
- Knowledge and appreciation for program area
- Basic computer literacy skills including word processing and emailing
- Detail oriented, ability to work independently, multi-task, and enjoys interfacing with other staff at all levels

- Ability to ensure safety for yourself and all program participants
- High degree of personal integrity and professional conduct
- High degree of flexibility and dependability
- Mandated Reporter Training (to be updated every 3 years)
- CPR/First Aid Certificate (to be updated every 2 years)
- Comfortable in front of large groups of campers
- Ability to create thematic programming weekly for a wide range of specialty themes
- Ability to write and prep lesson plans for counselor staff to lead with their group
- Ability to collaborate with program director, camp director, program counselors, head counselors, and counselors to ensure campers have an enriching specialty experience
- Ability to pass a driving test and drive groups on field trips using a 14 passenger camp bus
- Ability to act as leadership staff off site on field trips
- Ability to create and lead activities with campers ages 4-14

### **Preferred Job Qualifications**

- Certification related to program area
- High School Diploma or GED Certificate

### **Essential Job Functions**

- This position belongs to a class of employees referred to as Essential Personnel. Essential personnel are those needed on site to meet the needs of our camper and general camp operations. Essential personnel must report to work during their regularly scheduled hours, unless directed otherwise by a supervisor.

### **General Work Environment and Physical Demands**

The physical demands and work environment characteristics described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. This position requires the employee to be able to pass a Complete Background Check including the National Sex Offender Registry and work outdoors for long periods of time and in light rain, heat or cold. While performing the duties of this job, the employee is occasionally required to stand; walk; sit; run; use hands to finger, handle, or feel objects, tools or controls; reach with hands and arms; climb stairs; balance, stoop, kneel, crouch or crawl; talk or hear; taste or smell. The employee must occasionally lift and/or move up to 50 pounds. While performing the duties of this job, the employee is exposed to weather conditions prevalent at the time. The noise level in the work environment is usually moderate. This position is subject to a number of inherent risks associated with farm activities. There is a potential exposure to danger of animals.
